Frequently Asked Questions

Can I pay my premium in installments?

Yes, you can make a half annual premium payment to cover you for 6 months

Can I cover my Parent who is above 54 years?

Yes, you can cover them at an annual premium if they do not exceed 75 years.

What happens if I die?

Your trustees will contact us for Funeral Services and advise on continuity of the policy

When can't we pay a Claim?

- If death occurs within the waiting period except for Road Accidents,
- If Premium payment has been defaulted and New Waiting applies,
- If the provided Claim Documents do not match the Policy Details,
- If there has been forgery in the registration/ claim process

IMPORTANT NOTICES:

- ELIGIBILITY: Main Applicant should be 18-54 years, Children below 21 years and Parents not more than 75 years.
- **WAITING PERIOD:** From time of joining, there is a Waiting Period of only 6 months.
- PREMIUM PAYMENT: Subsequent premium should be paid before the ongoing cover period elapses. This would lead to a new Waiting period.
